Introduction

About a year ago, a visitor to the Memories of Arenzville group on Facebook asked me if I knew of a list of "Arenzville Civil War Veterans," and I replied that I would do some research. That's how the project started. My initial search produced about 55 names, but further research increased that number.

This project was motivated by the recognition that, in recent times, our local conversations and accounts of the past lack a full appreciation of those who served during the Civil War. These men answered a call to military service, and several of them did not come home. We have no right to let their names fall out of our community memory.

This year, as Memorial Day was approaching, I was preparing to drive back to Illinois from Atlanta, GA, when I remembered that some of the names of those men who were killed during active duty in the Civil War were soldiers who are buried outside of Illinois – in fact, I knew that a couple of those grave sites were on my way home. My visit to the graves of Henry Telkemeyer and James G. Fozzard further convinced me that the information about them and others must be gathered and shared. Those men rest so far from home. My wish is that their memory will always be a part of us.

I have tried to be inclusive in compiling this list, but at the same time, I needed to define some basis for which names to include. In many respects, compiling a list for the entire county would have been much simpler, but my purpose was to focus on Arenzville.

I recognize that this work is probably flawed and likely omits names which should be included. Likewise, I believe that some names on this list may also appear on lists of Civil War veterans of nearby communities such as Meredosia or Beardstown. But I do not know of any other list of Arenzville Civil War Veterans, and this is at least a starting point. If readers of this document would like to offer corrections or additions, I would welcome the suggestions. In the process of gathering information about these

men, I have also made additional notes and retained copies of some relevant articles about them, and I am happy to share with those who wish to make an inquiry. I can be contacted at this email address:

Methodology

The purpose of this project was to compile a document which provides a list of men from Arenzville, IL, who served in the military during the Civil War, and to gather biographical information about them.

Two issues quickly became apparent: 1) how does one define the scope of the community, and 2) what data sources can be found to document a list of names which meet the defined criteria?


What constitutes Arenzville?

Arenzville is a rural community, consisting of the village of Arenzville (population around 500 persons in 1860 and 367 persons today, according to the 2020 federal census) and outlying areas. Applying a strictly literal definition of Arenzville as confined to the village's town limits would exclude more than half of the population which considers itself "from Arenzville." Like most rural towns, the community has many residents in the outlying areas who are also considered part of the community. For the purposes of this project, I have used a broader definition of the community.

Defining "greater Arenzville"

From my own personal experience, having grown up in the community, the geographic footprint of "greater Arenzville" extends in all directions from the town – to a point. It crosses the county line, and it isn't a symmetrical radius. Most residents have an instinctive feel for the approximate boundaries, though there is certainly room for debate. Too far west, and one enters Meredosia territory; too far north, Beardstown or Bluff Springs; too far east, Virginia (and Monroe, in earlier years); and too far south, Arcadia or Concord. But defining that nebulous concept in terms of geographic representation on a map can be as fraught with pitfalls as trying to pin down the date of the first Arenzville Burgoo.

The present-day (2025) map of Arenzville's ZIP code (62611) is a fair representation of contemporary thinking of the community's boundaries (see image), though some may take issue with its extending all the way to the Illinois River or hooking around to encompass Cracker's Bend. These were likely territorial decisions made by the postal delivery authorities which had less to do with




sentiment of community belonging and more to do with managing limited resources for mail delivery. According to the U.S. Census, the ZIP code region covers an area of 72.58 square miles and contains a population of 978 persons.

Of course, there was no such thing as a ZIP code in the 1860's, and very likely the northeastern boundary of what was considered "greater Arenzville" would not have extended as far as today's ZIP code map. Attitudes about the extent of Arenzville's community at the time would have been influenced by the relatively recent abandonment of the community of Monroe, which lay between Arenzville and Virginia and was inhabited from 1818 to 1842. Though it was no longer populated by the mid-19th century, residents still considered that part of the county as the "Monroe" community. Twenty years after its abandonment, some men from that area of the county still described their residence as "Monroe, Cass County, IL" when they enrolled in the military.

References for rural locations in those days also relied on the terminology of the federal survey townships (sometimes also called Congressional townships) or civil precincts. For example, the village of Arenzville lies in the southwestern corner of Township 17N, Range 11W of the 3rd Principal Meridan. This point is located

in the civil precinct of Arenzville. But residents living in the adjacent precincts – i.e., Indian Creek precinct, Beardstown precinct, and Monroe precinct in Cass County, or Meredosia precinct, Concord precinct and Arcadia precinct in Morgan County – might also claim they were residents of "Arenzville."



These designations (as well as the slightly different federal township survey boundaries) are ones to keep in mind as one reviews the available records of Civil War veterans.

How do we determine if persons were from Arenzville?

To answer this question, we unfortunately must rely on imperfect information to determine facts as they were in 1860-1865. Even in those times, the population of the community was fluid and changing. In many cases, we simply do not have the benefit of complete records, though census records can be a starting point as a means to identify one's presence in the community.

The matter is not so simple as placing a dot on the map at the point of one's residence; sometimes belonging to the community was determined by where one's farmland or business lies or who one's parents (or spouse, or grandparents) were. Some young men were recent immigrants, working as hired hands for local farmers

and described in census records (if they could be found) as "lodgers" in a household which may or may not include their relatives.

Military records at the time often – but not always – recorded a man's place of birth as well as his residence at the time of his entry into service. Following the war, some men who had not previously lived in the community moved to Arenzville and spent the remainder of their lives there.

Any of these points suggests belonging to the community. As a starting point for this list, then, three criteria were established for inclusion. If evidence was found to document that an individual met any one of these three conditions, his name was added to the list.

- 1. He was born in Arenzville.
- 2. He resided in Arenzville at the time he entered service.
- 3. He is buried in Arenzville.

In each instance the broader definition of "greater Arenzville," as described above, is intended. Thus, someone born in the rural area near Arenzville would qualify; someone living on a farm near Arenzville around the time of the years of 1860-1865 or who stipulated "Arenzville" as his residence upon entry to service would qualify; and someone buried in one of several small private or family cemeteries near Arenzville would qualify.

This method will undoubtedly leave a few persons in a gray area – for example, on first glance, Edward Kuechler, born in Saxony and raised in Arenzville, does not meet any of the three criteria. Documents of his military service describe his residence as "Cass County, IL," and he is buried in Rushville. But census records of 1860 and 1870 show that he resided in the Arenzville precinct in those years. Likewise, August Hansmeier (Hansmeyer) meets the criteria, but his brother Simon (Samuel), a Beardstown resident, does not. The same is true for the Ginder brothers – James R. Ginder is noted in the record as residing in Arenzville upon entry to service, but the record for his brother Frederick Ginder states that he resided in Concord.

Starting point

With some definitions established for what constitutes an "Arenzville" person, the next challenge is to identify sources which

document information about an individual as well as evidence of his military service during the Civil War.

Records of Civil War service were compiled by the Adjutant General in each state, and data from these records are publicly available in both print and digital formats. Several online databases exist, both free and subscriber-based. These databases can be searched by the location of the veteran's residence on entry to service (if it was specified). The exact search methodology may vary by database. Some are more user-friendly than others. To compile a starting list, I made a search of each of the following databases, specifying "Arenzville" in the field for "residence" (or "lived in" or "keyword" or "any event, location"). Additional searches were done later using locations such as "Indian Creek," "Monroe," "Meredosia," etc., and those lists were kept for cross-reference.

- Illinois Civil War Muster and Descriptive Rolls Illinois State Archives (accessible at no cost on the Secretary of State's website; also accessible via Ancestry)
- Illinois Civil War Veterans of Missouri Units Illinois State Archives (accessible at no cost on the Secretary of State's website; also accessible via Ancestry)
- U.S., Civil War Soldiers, 1861-1865 (Ancestry; subscription required)
- U.S., Civil War Soldier Records and Profiles, 1861-1865 (Ancestry; subscription required)
- U.S., Civil War Roll of Honor, 1861-1865 (Ancestry; subscription required)
- American Civil War Research Database (Historical Data Systems; subscription required)

Limitations: A man's residence upon entry to service was not always recorded or may not have been so specific as the name of the town. For many soldiers, only the county of their residence was recorded. In addition, the spelling of the town name was not always accurate. Searches uncovered, for example, instances of the soldier's residence recorded as "Arnesville" or "Aunzeville." Area residents who enlisted in the military in another state may not appear in database searches as Illinois residents. Fortunately, the Illinois Secretary of State's database also includes tools to search for Illinois residents who served in Missouri units. a

common occurrence for many men from the Meredosia and Chapin areas.

List compiled

Alphabetical lists of names from the above sources were created using an Excel spreadsheet. This permitted a comparison of the lists to identify duplicate names. These occur because of differences in the spelling of names as they were transcribed from hand-written records, and also because names of some men may appear twice if they re-enlisted.

Additional sources consulted

Additional sources were consulted to identify more names. Published county and local histories were consulted for lists of names of Civil War veterans associated with Arenzville. Specifically, these sources were used:

- Perrin, William Henry. *History of Cass County, Illinois*. Chicago: O. L. Baskin & Co., 1882.
- Bateman, Newton, Charles Æ. (Charles Aesop) Martin, and Paul Selby. Historical Encyclopedia of Illinois: And History of Cass County. Chicago: Munsell Pub. Co., 1915.
- Lovekamp, Hester and Theodore. A Local History Collection of Arenzville, Illinois, self-published, 1989. (Note that this publication lists veterans buried in Arenzville cemeteries, but subsequent research showed that the list was incomplete and also several names of several persons for whom no record of military service could be found.)

Finally, each name was researched for additional information. This was done to confirm his identity and avoid confusion with others with identical names, as well as to confirm military service in the Civil War. Specifically, an attempt was made to identify the following information for each name:

- Birthplace
- Birth year (sometimes only an estimate could be made)
- Residence at enlistment
- Regiment in which he served
- Place of death
- Year of death
- Burial place
- Cemetery name

- Find-a-Grave listing number (if one exists)
- Spouse(s) (if any)

Various sources were consulted for this additional information. They include the following:

- U.S., Civil War Roll of Honor, 1861-1865 (Ancestry) –

- 1929 Illinois Roll of Honor contains the locations of the burial places of soldiers, sailors, marines, and army nurses who served in any of the wars of the United States (prior to 1929) and are buried in Illinois. Note that it will include veterans from wars other than the Civil War and veterans whose death may not have occurred during active duty.
- U.S., Registers of Deaths of Volunteers, 1861-1865 (Ancestry)
- U.S., Burial Registers, Military Posts and National Cemeteries, 1862-1960 – (Ancestry)
- U.S., Civil War Prisoner of War Records, 1861-1865 (Ancestry)
- U.S., Civil War Pension Index: General Index to Pension Files, 1861-1934 (Ancestry) This is an index only; not the full pension records.
- U.S., Civil War Draft Registrations Records, 1863-1865 (Ancestry) this database provides a list of men who are eligible for military service, grouped by the location of their residence. Those who are actively serving in the military or who have past military service are noted.
- 1890 Veterans Schedules of the U.S. Federal Census (accessible via Ancestry or Family Search)– this is a useful but limited resource. Nearly all of the schedules for the states of Alabama through Kansas and approximately half of those for Kentucky appear to have been destroyed before transfer of the remaining schedules to the

- National Archives in 1943. In Illinois, records from Cook County and Henderson County survived.
- 1910 and 1930 federal census records (accessible via Ancestry, census.gov or Family Search).

 Enumerated persons were asked if they were veterans. "UA" in the 1910 census denoted service in the Union Army, "UN" Union Navy, "CA"

 Confederate Army, and "CN" Confederate Navy. In the 1930 census, enumerators listed abbreviations for wars or expeditions, such as "WW" for World War I, "Sp" for the Spanish-American War, and "Civ" or "CW" for the Civil War. However, notation of the military service was often omitted, and these records alone are not sufficient evidence of service.
- Obituaries and other published news items consulted via Newspapers.com, Newspaperarchives.com (subscription services) and online newspaper databases available via community libraries.
- Find-a-Grave Listings this information was consulted as a secondary source for dates of birth/death and names of spouses. When a veteran's listing was identified, it was noted using his listing number, and the location and name of the cemetery were also recorded in compiled list.

The resulting list on the following pages includes 94 names, though two of these may be duplications.

He served in infantry units in both Missouri and Illinois. Veteran datases describe him as a deserter in 1865 when he failed to return from furlough to Meredosia, but this could be an error. He applied for an invalid's pension in 1887, and the record shows service in both MO and IL companies. His grave marker shows service in the "11th IL Inf," but this does not agree with other records. He lived in Bath, IL, for a few years after his marriage.
